- And whereas, the Rizvi College of Education, New Rizvi Educational Complex, Sherly Rajan Road, Off. Carter Road, Bandra (West), Mumbai- 400050, Maharashtra by affidavit dt. 06.01.2015 has consented to come under new Regulations and sought for one basic unit in B.Ed., which require additional facilities
- And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

This is in response to the show cause notice dated 15.02.17 enclosing thereto copy of letter No WRC/APW0721/123005/MII/2016/180454 regarding fulfillment of conditions by Rizvi College of Education, with respect to intake of two basic units of 50 students each for the two year B.Ed. Course.

On the onset, I, Dr. RadhikaVakharia, Principal of Rizvi College of Education, Bandra, Mumbai 400050, apologise for the delay in responding to the aforesaid letter. I would like to place before you the following facts and certain unforeseen circumstances under which I plead you to make changes in the student intake in our college.

- In January 2015, we were asked to send the confirmation of the Recognition of the B.Ed. Course (2 year Revised course). We did the same on 8<sup>th</sup>January 2015, wherein we asked for 2 units of 50 students each for the course.
- 2. On 31/5/2015 vide no WRC/OAPW0721/123005/2015/140161, we got permission from the NCTE for 2 units of 50 students each, from the academic session 2015-16 subjected to the institution fulfilling the requisite conditions.
- 3. During the academic year 2015-16, the year in which the two year B.Ed. course was introduced we could make only 42 admissions as against the 100 sanctioned (i.e. 2 units).
