Memorandum of Understanding (MOU) Between Rizvi Education Society's, Rizvi College of Education And ADAPT Centre

This Memorandum of Understanding (hereinafter referred to as "MOU") dated 1st March, 2024 is made and entered into by and between Rizvi Education Society's, Rizvi College of Education, whose address is New Rizvi Education Complex, Off Carter Road, Bandra (West), Mumbai 400050 (hereinafter referred to as "RCoEd") and ADAPT whose address is KC Marg, Nityanand Nagar, Reclamation, Bandra West, Mumbai, Maharashtra 400050 (hereafter referred to as ADAPT).

WHERE AS:

RCoEd is a teaching training institution of Mumbai, recognized by NCTE and affiliated to the University of Mumbai and ADAPT formerly known as The Spastics Society of India is an Indian non-profit and non-governmental organization, working to help people with neuro-muscular and developmental disabilities.

Background:

Rizvi College of Education (RCoEd) and ADAPT Centre recognize the importance of fostering collaboration and promoting experiential learning opportunities for students. Both institutions aim to facilitate the professional development of B.Ed. students by providing them with internship and community work opportunities.

Purpose:

This Memorandum of Understanding (MOU) outlines the terms and conditions under which RCoEd students will engage in internship and community work activities with ADAPT Centre.

Terms of Agreement:

1. *Internship Duration:*

RCoEd students will undertake internship and community work activities at ADAPT Centre for a duration of one week to one month in accordance with the University academic calendar during the months of January and April. The specific dates will be mutually agreed upon by both parties based on the availability of resources and facilities.

2. *Roles and Responsibilities:*

- a. RCoEd will nominate competent B.Ed. students to participate in the internship program.
- b. ADAPT will provide necessary guidance and supervision to the interns during their tenure.
- c. Both parties will collaborate to develop a structured internship program that aligns with the academic curriculum and learning objectives of the students.

3. *Activities:*

The internship and community work activities may include but are not limited to:

- Assisting in educational programs and activities conducted by ADAPT Centre.
- Participating in community outreach initiatives and events.
- Engaging in research projects or educational workshops, as assigned by ADAPT.

4. *Resources and Support:*

ADAPT will provide necessary resources and facilities to support the interns in carrying out their duties effectively. RCoEd will ensure that students comply with the rules and regulations of ADAPT during their internship period.

5. *Evaluation and Feedback:*

Regular evaluations of the interns' performance will be conducted by ADAPT Centre. RCoEd may also provide feedback on the internship experience to ensure continuous improvement.

6. *Confidentiality:*

Both parties agree to maintain confidentiality regarding any sensitive information or proprietary data shared during the internship period.

7. *Commercials:*

There is no financial obligations of any kind on either party

Termination:

Either party may terminate this agreement upon written notice to the other party, with a minimum notice period of one month. Termination of the agreement will not affect any ongoing internship activities, which shall be completed as per the agreed-upon terms.

Amendments:

Any amendments or modifications to this MOU must be made in writing and agreed upon by both parties.
